A. The District Manager reported that after doing research on getting 5-hp pumps for station #7 he found they will not work due to having single base power. The drives

are big enough to handle 5hp, but since they are already converting the pumps to 3-phase they would not be able to run faster and they would run only half of the speed. To change that we would have to purchase larger drives which is way too costly. The District will just keep flushing the line a couple of times a year to keep the flow moving in the pipes.

B. The District Manager has been discussing, with the Dyer Engineer, the design of the RV dump to make the maintenance more efficient and accessible. A copy of the proposed drawings were sent to Commissioner Boice for his input but has not received a reply.

## New Business

A. After the District Manager gave Tom VonFlatern a positive evaluation, Bill Taylor moved, and Bob Greig seconded to give Tom a dollar per hour wage increase beginning March 1, 2021. Motion passed unanimously.
